- This year the Rochester Map Adventure returns to the schedule and we will be introducing a four event Summer Score O Series. We will also be hosting an OUSA National Ranking Event at Letchworth West in May. This is an enhanced local meet that features seven courses and assigned start times for Orange Blue courses. Each club is being allowed to offer one NRE without paying any additional sanctioning fees normally required. We will call this meet the Western New York Championships and hope to attract a larger, competitive field and ranking points.
- The other part of our committee function is to make sure that suggested venues have updated or new maps. This year we will need to update Seneca Park and Basil Marella Park. We will continue to map other areas of Alasa Farms and hope to do orienteering quality maps for Harriet Hollister and Cumming Nature Center.
